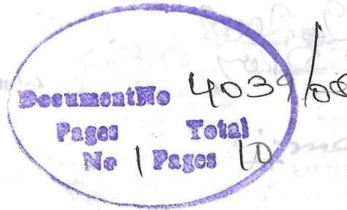

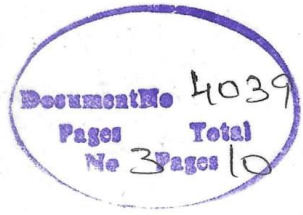

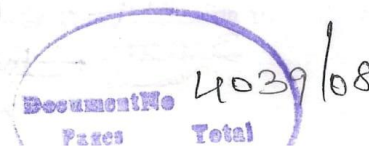

Extending the advance Art and Literature Creations before the people. Establishing the Environmental Institutes, Laboratories and Documentation Centers.

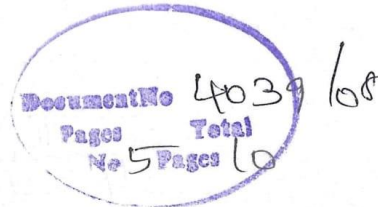
Creating awareness among the people for the protection of the Environment & Natural Calamaties.

The trust may enter into contract or agreement or any other transactions for the purpose of promoting the aims whenever applicable with prior permission from the authorities.

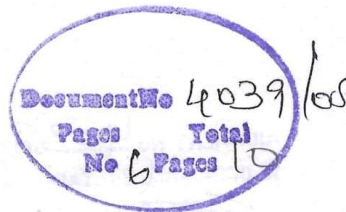
The trust is empowered to take on lease, license, hire or otherwise required to hold manage, administer deal with movable and immovable property that Board deems necessary, to be acquired in future.

To sell, alienate, lease, mortgage, charge pledge, hypothecate, transfer or otherwise deal with all properties funds and assets, or the trust as the board may deem fit, to be acquired in future.

To appoint, persons, representative agents on other works on such conditions as may be thought necessary by the Trust.

The trust funds acquired or earned shall be solely utilized towards fulfilling of the objects and no portion of it shall be utilized for payments to trustees by way of profit interest or dividends or otherwise. The programme and benefits shall be open to all those who need as the case may be, without profit motive.

To carry out the objects general public utility not involving the carrying on of any activity for profit motive such as the establish, run, maintain and develop public hall, cyclone relief centers, communal riot relief centers, homes for the aged destitute men, women and children, on no loss no profit basis.

To Institute Scholarship, Stipends, Studentship, Prizes and provide monetary aid to deserving students for the purpose of pursuing their education.

To establish, maintain, run, develop, improve, extend, grand, donate and to aid in the establishment, improvement and extension of Libraries, Reading Rooms, Meeting Halls, Educational Centers and other facilities as are calculated to be of use in imparting Education to the Public without any profit motive.

To start and maintain and develop and run Vocational Training Centers, Rehabilitation Centers for Poor and Old and Sick and Infirm or Destitute Womens and all the needy people for charity purpose not for profit motive.

To conduct Poor Feedings and to give Food, Clothes, Cash grants to the poor and afford relief to peoples in distress and affected by Earthquake, Flood, Famine, Pestilences, Tsunami and other Cases, all of the Natural Calamity and to the Orphans, Rescue Home, and similar Institutions and Societies and Education to the Helpless.

To give training for Music Classes, General Knowledge Development, Spoken English & Hindi Classes, Personality Development Courses, Computer Courses, Tailoring Courses, Adults Literacy Programme, Beauticians Courses, Cottage Products Trainings, Handicrafts Works Trainings, Social Welfare Development, Environmental Programmes, Awarness Camps & Legal and Counselling Assist,etc. without any profit motive.

To purchase Land for the purpose mentioned above to do all such things necessary for the same such as enter into agreements, makes payments etc to be acquired in future.

To put up the Constructions of buildings required for the above mentioned purposes and purchase and install equipments and to do everything necessary to achieve the above objects to be acquired in future.

The above said Objects and Clauses are only for Charitable purpose and not for any profit motive, every subject to be process only with prior approval from the concerned authorities and approval from the Boar of Trustees of the Trust.

### POWERS OF THE FOUNDER/MANAGING TRUSTEE:

The Founder/Managing Trustee have got full right and power at any time to alter, or change the nomen, clature of the trust board and also to remove, and change and altre the members of the only through Resolution passed by all the Trustees of the Trust unanimously and prior permission from the Director of Income Tax.

### BANKING ACCOUNTS

The Trust Board shall open one or more bank accounts in the name of the Trust, All income of subscriptions and pecuniary donations for the general purposes of the trust and the income from investments and all other money received from time to time forming part of the general revenue of the Trust shall be paid into one or more Nationalized Banks in India. The Banking Account or accounts be operated by the **Founder/Managing Trustee Individually**. In future the Trustees wants to operate the Account with Two Persons Jointly, they have to pass the Resolution and Signed by the all the Trustees unanimously and inform to the authorities.

### ACCOUNT & AUDIT

The Founder/Managing Trustee shall keep proper books of account all income and expenditure of the trust and shall prepare on income and expenditure account and balance sheet as on 31<sup>st</sup> day of MARCH of every succeeding English Calendar Year. The Account of every year shall be audited by a Chartered Accountant of firm or Chartered Accountants. The C.A. or the firm shall be appointed by the Board of Trustees every year (Expln. to Section 288 (2) and the Income Act 1961).

The Founder/Managing Trustee herein may maintain a list of advisors for better administration of any particular objects by engaging their services with approval from the Board of Trustees.

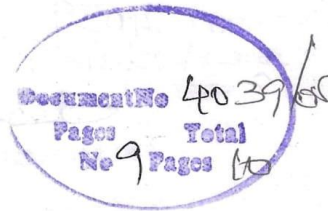
## TURST FUND

Donation Received, Donation & Assistance Received from Public & Govt. and Institutions. Voluntary contributions made with specific directions from part of the corpus of the trust. Foreign contribution / Donations / Gifts in the form of articles, currency whether Indian or Foreign, Foreign Security, subject to the provision of Foreign Contribution (Regulations) Act., 1956.

## GENERAL FUNCTION & AMENDMENTS

1. This Trust shall be irrevocable. Though this Trust shall be irrevocable, the Board of Trustees may subject to the prior approval of the Director of Income Tax (Exemption) amend any of the clauses contained herein in relation to the Management of the Trust at a duly convened meeting of the Board of Trustees by a Resolution passed unanimously passed by all the Trustees.
2. If the Trust hereby constitutes fail for any reason in the opinion of Founder / Managing Trustee of the trust the net assets of the Trust both movable and immovable shall be handed over any public charitable trust as decided by the Board of Trustees by passing Resolution.
3. In the event of dissolution of the trust the assets and liabilities, if any shall transferred to another trust which has similar object and enjoying Exemptions U/s. 11 and 80G of the Income Tax Act.
4. The Trust shall invest its income available for investment from time to time in specific mode of investments as per section 13 (i)(d) read with sec.(ii)(5) of the Income Tax Act, 1961.
4. The Income and funds of the Trust shall be solely utilized towards the objects of the Trust and no portion of its income shall be utilized for payment to trustees by way of remuneration, profits, interest, dividends, etc., in section 13(I) of the Income Tax Act, 1961.
5. The Income and Fund of the Trust will be solely utilized towards the objects of the Trust only, and not more than 5% of the funds will be utilized for payments to Trustees by way of profits.

6. Any amendment to the instrument would be carried only with the approval of Director of Income Tax (Exemption). Acquisition / alienation of immovable property shall be done with prior approval of the Director of Income Tax (Exemption).
7. The benefits of the Trust are open to all in the Society at large irrespective of caste, creed, religion, sex etc.,
8. The activities and functions of the Trust shall be utilized only towards charitable purpose and not for any profit motive.
9. The activities of the Trust shall be carried on only within the Union of India and shall not be carried on any where out side India.
10. At present the Trust have no immovable property. No activities of the Trust will be carried out any where India, without prior permission from the appropriate /concerned authority of Director of Income Tax.

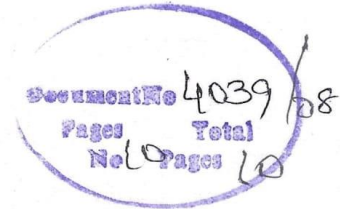

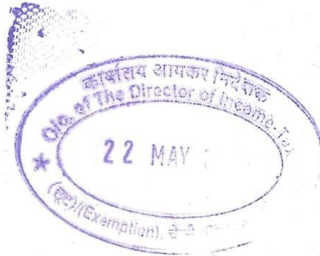
